

E-Sign up Important Information



By clicking on the Submit button on the online application form to join the Crescent Wealth Superannuation Fund, I:

- apply to be a member of the Crescent Wealth Superannuation Fund and the application is made in Australia.
- acknowledge that I have received all information I require in order to exercise the choices I have made.
- accept that I will be bound by the provisions of the trust deed and designated rules which govern the operation of the Super fund.
- understand and consent to my information being collected, disclosed and used in the manner set out in the Privacy Policy.
- acknowledge that by providing my email address in the online application form, the trustee and fund may, at its discretion, use that email address:
 - to send me information concerning my super, member and exit statements, notices or occurrence of significant events and other member communications; and

Online access to this account will be given to any person who uses my login details.
